Course Program

1. Description of the course, its goal, field of study and learning outcomes

The course is targeted to form students' views on business as a sphere of self-realization and personal development, and the implementation of entrepreneurial activity through combination of freedom of contract, social nature of society and the regulatory function of the state. Next to the classic sphere of relations between business and government (vertical relations, including: the establishment / termination of business activities, licensing, taxation, compliance with standards, financial solvency requirements to avoid insolvency) this course pays attention to building horizontal links in the business environment (private law contracts), as well as to the role of the state in safeguarding the "rules of fair play" at the commercial arena. Particular attention is paid to combining the social and economic components of entrepreneur's status (review of various forms of attracting talents and protecting investments made into the development of intellectual capital) and foreign economic activity.

2. Prerequisites and post-requisites of the course (place in the structural and logical scheme of education according to the respective study program)

Study Item 9. Creditors' claims, litigation to settle disputes and financial solvency recovery instruments

Course Policy and Assessment

5. Course (study component) policy

Students are welcomed to attend lectures and no attendance control at lectures is assumed. In the course of the lecture students have an opportunity to initiate certain discussion on an issue of his particular interest within the lecture respective focus.

Students are required to attend practical / seminar classes, to perform a modular / home assignments and to be present at the class on the day of the terminal (semester) examination.

When preparing for a practical / seminar class, students should pay attention to the material advised in the respective lecture, as well as other recommended sources (as concerns certain practical / seminar class).

When performing an individual / team assignment, the use of illustrative materials is encouraged however is subject to the choice of such student / team. Nevertheless, completing assignment in written remains mandatory (regardless of the use of any presentations, video clips, mindmaps, etc.). Another approach to complete an assignment may be acceptable subject to having it agreed with the professor in advance.

An the performance of any written assignment, due regard shall be paid to academic integrity aspects. Certain assignments may have certain specific requirements compliant with the legislation and the University rules and regulations.

A proper way to submit written assignment is to upload respective file to the Moodle location, unless otherwise agreed in advance with the professor.

6. Types of control and rating system to assess learning outcomes

On-going control: topic specific discussions

Regular control: review twice a semester to monitor learning requirements compliance (not applicable to part-time (remote) students)

Terminal (semester) control: pass/no (non-graded examination) Control admission requirements (access to semester control): score is higher than 40 rating points

The total score of the student accumulated within the semester may be up to 100 points. The components of the total score include, in particular: on-going student work at the practical classes: 1 or 2 points per class (not to exceed 36 points per semester), individual assignment, initiative to prepare essays on problematic issues with its further presenting to other students: up to 10 points per class (not to exceed 30 points per semester), team assignment to work out in groups: up to 10 points per team per class, as well as control assignment (thematic / modular): up to 10 points per work (not to exceed 30 points per semester).

A student whose score resulting from the semester is less than 40 points shall not be admitted to pass the examination. And if a student's score is 60 or points or higher, the "pass" status may be assigned (based on the number of points scored during the semester).
